School management of a positive COVD case on site

- Parent/carer notifies school of a positive PCR test result. No actions taken for a positive RAT (unless student is a close contact of a student who previously returned a positive PCR test). Text message from Health confirming positive case also identifies period of isolation and testing dates for that person.
- Principal reports student name, age and class details to DoE COZID Incident Management Team (IMT), principal liaison assigned to advise next steps
- Principal determines infections period of positive case: either two days before symptoms started, or 2 days before positive PCR swab was taken (whichever is earliest)
- Principal determines whether the positive person was on site during infectious period. If YES, principal identifies students and staff who had either 15 minutes face-to-face contact not wearing masks, **or** more than two hours in a small room (including classroom) not wearing masks. If NO, no close contacts identified and no further effects to staff and students.
- Principal determines key quarantine and testing dates for close contacts. Day of exposure becomes "Day 0" of quarantine. To exit quarantine, all close contacts must return a negative result from either a PCR test taken on "Day 6" or a RAT on "Day 7".
- Principal drafts communications explaining situation and those affected, including quarantine instructions for close contacts, sent out to entire school community
- Home learning resources and processes provided to positive cases and close contacts: if most of a class and their teacher are required to isolate, students added to "Year X Home Learning" Connect class for access to resources and teacher (if asymptomatic) sets time to check in regularly with members of the class through WebEx. If individuals test positive and no close contacts need to isolate, individuals will be added to "Year X Home Learning" for access to resources which parents can access to work through at a time and pace that suits the family's arrangements.
- Parent/carer notifies school administration team (Principal, Deputies and front office staff) of negative result on "Day 7"
- Close contacts return to school on "Day 8" provided they are asymptomatic **and** have returned a negative test **and** no new household members have returned a positive test
- If close contact returns a positive result, principal follows previous steps listed above to determine new infectious periods, close contacts and periods of quarantine if applicable

School management of close contacts from external exposure

- Parent/carer notifies school of student's close contact status
- Principal determines key quarantine and testing dates for close contact. Day of exposure becomes "Day 0" of quarantine. To exit quarantine, all close contacts must return a negative result from either a PCR test taken on "Day 6" or a RAT on "Day 7".
- Principal advises family on other aspects based on current Health advice, ie: a parent isolating with a child who still requires hands-on care, whether siblings are required to isolate, etc.
- Parent/carer notifies school administration team (Principal, Deputies and front office staff) of negative result on "Day 7"
- Close contacts return to school on "Day 8" provided they are asymptomatic **and** have returned a negative test **and** no new household members have returned a positive test
- If close contact returns a positive result, principal follows previous steps listed above to determine new infectious periods, close contacts and periods of quarantine if applicable

Shaping the future

School-based close contact in a high caseload environment Testing and isolation advice for schools

Close contact definitions in schools

Face-to-face

At least 15 minutes faceto-face contact where a mask was not worn by the exposed person and the person with COVID-19.

Small indoor space/classroom/no mask

Greater than two hours within a small indoor space or classroom environment, where masks have been removed for this period by the exposed person and the person with COVID-19 (note others wearing masks in this scenario would not be a contact). Advised by WA Health Someone who is directed by WA Health that they are a close contact.

Confirmed positive case

Notify your school and isolate for a minimum of 7 days.

At Day 7, if symptoms are present



- remain in isolation until symptoms clear • If no symptoms after Day 7, leave
- isolation and no testing is required.

Symptomatic close contact

Notify your school. Quarantine for a full 7 days from the last date of contact with positive case; and take a PCR test or a RAT on Day 1 or as soon as possible:

- · if positive refer to Confirmed positive case
- If negative PCR, continue to quarantine
- If negative RAT, continue to quarantine and take RAT in 24 hours
- if RAT positive refer to Confirmed positive case. You must report your positive RAT.*
- if RAT negative continue to quarantine.

Take a PCR test on Day 6 or a RAT on Day 7:

- If positive refer to Confirmed positive case.
 You must report your positive RAT.*
- If negative and no new household members have tested positive – quarantine ends after Day 7, and people should monitor for symptoms.

Asymptomatic close contact

Notify your school. Quarantine for a full 7 days from the last date of contact with positive case; and take a PCR test or a RAT on Day 1 or as soon as possible:

- if positive refer to Confirmed positive case
- if negative PCR, continue to quarantine
- if negative RAT, continue to quarantine and take RAT in 24 hours
- If RAT positive refer to Confirmed positive case. You must report your positive RAT.*
- If RAT negative continue to quarantine.

Take a PCR test on Day 6 or a RAT on Day 7:

- If positive refer to Confirmed positive case. You must report your positive RAT.*
- If negative and no new household members have tested positive – guarantine ends after Day 7, and people should monitor for symptoms.
- If symptoms develop, refer to Symptomatic close contact.

Symptomatic (not a close contact)

Get a PCR test immediately and isolate until the result is returned:

- if positive, refer to Confirmed positive case
- If negative, not required to isolate but should stay home where possible until symptoms clear.
- If you take a RAT because a PCR test is unavailable:
- if positive, refer to Confirmed positive case. You must report your positive RAT.*
- if negative, continue to isolate and repeat RAT in 24 hours

 if negative after this follow-up test, you are not required
 to isolate but should stay home until symptoms clear.
